Publication scheme charges

Most of the information we provide under our publication scheme is available on our website free of charge.

Our [Information Access Fees Policy](#) outlines the legislation that applies to when we will charge a fee to provide the information we hold, and how any fee will be calculated.

If you require printed versions of the information available on our website, or information which is archived and no longer on our website, we reserve the right to impose a charge for providing this information in paper copy. In these instances, we will issue a fee notice (payable in advance of complying with the request) charging for photocopying or printing at a rate of 10p per sheet of paper. We will charge postage at cost. The GDC Information Governance Manager should agree to any decision to request payments.

Hearing transcripts

The GDC does not produce publicly available versions of hearings transcripts as a matter of routine. If you wish to obtain a transcript of a Fitness to Practise (FTP) panel hearing, Registration Appeal hearing or Specialist List Appeal hearing, we reserve the right to charge the full cost of producing a public version. These costs are variable and will include the cost of our quality assurance processes to ensure that information we regard as confidential – for example, information about a registrant's health, and the names and contact details of patients or vulnerable witnesses - are removed prior to publication.
