The General Dental Council (EU Exit) (Amendment) Regulations 2020

The General Dental Council makes the following regulations in exercise of the powers conferred by section 19, section 26, section 36F, and section 52 of the Dentists Act 1984.

Citation, commencement and interpretation

- 1. These regulations may be cited as The General Dental Council (EU Exit) (Amendment) Regulations 2020.
- 2. These regulations shall come into force on exit day.
- 3. "The European Qualifications Regulations 2019" means the European Qualifications (Health and Social Care Professions) (Amendment etc.) (EU Exit) Regulations 2019.

Amendment of the General Dental Council (Dentists) (Fees) (No.2) Regulations 2019

- 4. Regulation 2(1)(d) is omitted.
- 5. Regulation 2(2) is omitted.
- 6. In Regulation 3 reference to Section 15(1)(b), Section 15(1)(ba) and Section 17(1) of the Dentists Act 1984 is omitted.
- 7. The amendment made by Regulation 5 shall not apply in the case of applications for registration governed by the transitional provisions in paragraph 37 of Schedule 3 to the European Qualifications Regulations 2019.

Amendment of the General Dental Council (Profession Complementary to Dentistry) (Fees) (No.2) Regulations 2019

- 8. In Regulation 2(1)(b) reference to subsection (3) of section 36C of the Dentists Act 1984 is omitted.
- 9. In Regulation 2(1)(c) reference to subsection (3) of section 36C of the Dentists Act 1984 is omitted.
- 10. Regulation 3(3) is omitted.

Amendment of the General Dental Council (EU Exit) (Amendment) Regulations 2019

11. After Regulation 14, insert -

"Transitional and savings provision

- 15. The Rules and Regulations amended by these Regulations shall continue to apply without the amendments made by these Regulations until the end of the Implementation Period.
- 15. "Implementation Period" has the meaning given in section 1A(6) of the European Union (Withdrawal) Act 2018.

Transitional and savings provisions

- 12. The General Dental Council (Dentists) (Fees) (No. 2) Regulations 2019 and the General Dental Council (Professions Complementary to Dentistry) (Fees) (No. 2) Regulations 2019 shall continue to apply without the amendments made by Regulations 4 to 10 of these Regulations until the end of the Implementation Period.
- 13. "Implementation Period" has the meaning given in section 1A(6) of the European Union (Withdrawal) Act 2018¹.
