Introduction

Overview

We maintain a register of dental professionals who meet our standards and can lawfully practise dentistry in the UK.

Everyone who joins the register must be suitably qualified, or pass an assessment, and meet health, character, and English language requirements to be considered fit to practise as a member of the dental team.

There are several routes to registration:

- A recognised UK qualification.
- · A relevant European diploma.
- A recognised overseas qualification.
- An assessment of suitability to register, via a GDC panel assessment of skills and knowledge.
- A pass in Parts 1 and 2 of the Overseas Registration Examination.


We register the whole dental team, across the four nations of the UK. This includes dentists, dental nurses, dental hygienists, dental therapists, orthodontic therapists, dental technicians and clinical dental technicians.

Specialist lists

We maintain lists of dentists who are suitably qualified or experienced to be considered specialists in specific areas of dentistry.

Continuing Professional Development (CPD)

All dental professionals must keep their skills and knowledge up to date during their career. Undertaking CPD is a requirement of registration with the GDC. These requirements vary by dental profession, but all dental professionals must complete at least ten hours of CPD over each two-year period.

Dental professional numbers

The total number of dentists and DCPs on the register

This table shows the total number of dentists and dental care professionals (DCPs) on the register as of 31 December 2023. DCPs who have more than one title, for example a dental hygienist who is also a dental therapist, are only counted once in this table.


There was a 3.9% increase in the total number of dental professionals on our register, from 115,541 at the end of 2022 to 120,030 at the end of 2023.¹

The number of dentists on the register has increased over each of the last five years. In 2023 the number of dentists increased by 2.4%, compared to 2022.

The total number of DCPs on the register increased by 4.9% in 2023 compared to 2022.

Total number of dentists and DCPs on the register 2019 - 2023





There was a 5.4% increase in the overall number of registered titles in 2023, from 122,432 in 2022 to 129,052 in 2023


Number of dental professionals on the register 2019 – 2023 by profession



Overseas Registration Examination (ORE) and Rest of the world qualified both represent overseas qualified dentists who are registered to practise in the UK. They both hold a primary dental qualification equivalent from a Non-EEA country. The ORE is a statutory examination and the Rest of the world qualified have demonstrated suitability via the registration assessment route.


Dentists on the register by region of qualification 2019 – 2023

Dentists and DCPs added to the register in 2023, by region of qualification

In 2023, the Registration function concluded 11,476 applications across all routes, a significant increase on a previous maximum of 8,979 applications, completed in 2015. In addition, the time taken to progress all applications for all routes to registration improved in each area.

Following the substantial and unprecedented number of international DCP applications (circa 5,700) received by 8 March 2023 (when this route to registration closed), we recruited additional Caseworkers to support the progression of all application routes. By the end of 2023 over 2,000 applications had been assessed by registration assessment panels, resulting in over 1,200 registrations.

We continue to progress this high number of applications, and this continues to be a focus for the department.





New additions to the dentist register by region of qualification 2019 – 2023




Due to the pandemic, the ORE Part 2 (an in-person examination) was not held between February 2020 and December 2021.




There was a 3% decrease in the overall number of dentist removals, from 1,315 in 2022 to 1,274 in 2023. Of these removals, 114 went on to restore to the register in 2023.



There was a 17% decrease in the overall number of DCP removals², from 5,179 in 2022 to 4,322 in 2023. Of these removals, 356 went on to restore to the register in 2023.







Working pattern date

In March 2024 we published, for the working pattern data for dentists. This was data provided voluntarily by dentists as part of their annual renewal process. We are completing a similar exercise for DCPs as part of their annual renewal process later in 2024.

Register profile - equality and diversity

The charts below show our registrant profile analysed with reference to the nine Equality Act protected characteristics³.

The EDI data we hold about dental professionals is provided by them voluntarily. We currently hold EDI data for around 94% of dental professionals.

We encourage all dental professionals to provide their EDI details as part of our commitment to store the right data in the right format to help assess the proportionality of its processes.⁴

We continue to develop our understanding of what this data is telling us, and more importantly how we can use this data to analyse these characteristics within the context of our registers.

One of the key objectives in our 2021 – 2023 Strategy was to better understand the diversity of those we regulate. Now we have this data we will use it to inform our policies and procedures and to ensure that we are proportionate and fair.

We also use registrant EDI data to understand the changing profile of the register and whether some groups are more likely to join or leave the register. It is important that we collect this data as part of our role as a regulator, to show we understand the diverse nature of the dental workforce. We also collect protected characteristic data on GDC panellists and associates to help us ensure both groups have a diverse population.

Our updated EDI Strategy is currently being finalised and will build on the ambitions of our existing strategy. Our aspiration is to work with the wider profession to embed equality, diversity, and inclusion not just across what the GDC does, but also around how dental professionals work with patients and each other going forward. This will include encouraging others to put EDI at the forefront of their working practices.

Dental professionals with disabilities in 2023

Less than 1% of dentists or DCPs identified as having a disability. The numbers here are exceptionally small, which may be due to the understanding of what is meant by the term 'disability.' Under the Equality Act 2010, a disability is described as a physical or mental impairment that has substantial and long-term negative effect on the ability to carry out normal activities. This could include long-term health conditions, depression, and anxiety, and neurodivergent conditions.

^{4.} We currently do not collect data on pregnancy / maternity. Bases sizes for disability status and Gender Identity categories did not provide enough variation to report on. Overall counts can be found in the registration report.




The proportion of females who were new to the register in 20236




Dentist age groupings as of 31 December 2023



Age group growth and decline


Net growth or decline in dentist age group 2019 - 2023



The 22-30 is the largest age group in positive net growth. In 2022, we saw a 36% year on year increase in the net positive growth (i.e more people joining the register at this age, than leaving the register).

In 2023, this increased volume of net positive growth was still present (With 1,502 more people joining the register than leaving it).

The 16-21 and 22-30 age groups have both seen growth in numbers since 2019, however the pattern is quite different. The number of 16-21 year olds on the DCP register, grew by nearly a thousand (994) in 2023. However, the next age-group (22-30 year olds) grew by nearly double this number in 2023 (1,844).


The other age groups all show a consistent trend of more registrants leaving the register than joining (net decline).














Dentist numbers by sexual orientation 2023


